

## **Summit Materials Environmental Policy**

Summit Materials, Inc. (the "Company") strives to be a steward of the environment, recognizing the need to operate its business in a manner that reflects thoughtful environmental management. The Company's environmental policy applies company-wide, including all subsidiaries, business operations, and facilities. The Company is aware of the potential environmental impacts resulting from the construction and aggregates industry. The Company's goal is to balance its business operations with the need to protect local and global environments, and reduce the Company's environmental footprint.

In an effort to accomplish this, the Company will:

- **Environmental Compliance:** Comply with Company policies and procedures and all applicable environmental laws and regulations.
- Education and Training: Work to provide education and training to Company employees and leadership regarding applicable environmental laws and policies as well as promote a culture of minimizing the Company's environmental impact.
- Conduct Reviews: As needed, conduct reviews of operations and facilities to ensure and verify compliance with applicable environmental laws and regulations to identify and address any operational practices that may be negatively impacting the local environment.
- **Climate Change:** Where practicable for the Company, reduce greenhouse gas emissions through minimizing the use of energy and the use of non-renewable resources and, where feasible, replacing non-renewables with alternate raw materials and fuels.
- **Water:** Whenever possible, reduce the Company's impact on water resources by limiting ground and surface water use through recycling and minimizing wastewater discharges.
- Reduce, Reuse, Recycle: Work to reduce and reuse products whenever possible from a business and consumer standpoint. We encourage the Company's operations to recycle business, production, and consumer waste as an impactful approach.

- Waste Disposal: Work to minimize the generation of waste, and dispose of all waste in compliance with applicable environmental laws and regulations.
- **Biodiversity:** Encourage and work to implement meaningful conservation programs on lands where the Company operates or has operated to enhance biodiversity, protect ecosystems, and expand the Company's contributions to land conservation.
- Reclamation: Upon completion of mining use, lands on which the Company operates shall be reclaimed in accordance with the closure plan, applicable laws and permitting. Whenever possible and where feasible, native plants should be considered during the planning process to further promote wildlife habitat.
- Partners: Aim to establish partnerships with local and national organizations to provide frameworks for evaluating environmental and community projects with meaningful, positive impact.
- Technology: Work to implement technologies and operating procedures to minimize environmental impacts, optimize the Company's over-the-road fleet, and reduce waste whenever possible.
- Due Diligence: As applicable, conduct environmental due diligence in connection with the Company's acquisitions.
- Stakeholders: Maintain an open and honest dialogue with our stakeholders. Work to educate stakeholders about the Company's operations while encouraging their feedback and ongoing communication.
